**1. INTRODUCTION:**

a. The safety and enjoyment of the members of the community are of primary concern in the operation of our pool at Two Creeks Recreation Club. Please show courtesy and consideration for others during use of the pool and cooperate with the lifeguards in their daily management of the pool.

b. Lifeguard(s) will be in charge of the pool area when on duty. We ask for your cooperation with the lifeguards' directives or requests regarding safety, abiding by the rules and guidelines, and curtailing any activity that interferes with the swimming enjoyment of others.

**2. SCHEDULE & HOURS OF OPERATION:**

- a. March 1, 2007 - October 31, 2007  
6:00 am to 10:00 pm

**Lifeguards on Duty:**

- b. The pool will be staffed with lifeguards when school is not in session for the summer.

**For lap swimming, please ask the lifeguard to install the lane ropes to allow for dedicated lap lanes, not to exceed two lanes.**

The Swim Club and/or Pool Manager reserve the right to close the pool at any time for emergency repair or weather purposes.

**FOR LIABILITY PURPOSES - NO ONE UNDER 18 IS ALLOWED IN THE FENCED POOL AREA UNLESS ACCOMPANIED BY AN ADULT OR A LIFEGUARD IS ON DUTY. ONE CARD KEY (DOORKING) IS ISSUED PER FAMILY AFTER WAIVER IS SIGNED.**

**There is a \$50.00 charge for lost or missing keys.**

### **3. ENTRY AND POOL USE:**

a. **PERSONS USING THE POOL DO SO AT THEIR OWN RISK.** The Recreation Club is not responsible for accidents, injuries or loss of personal property. The ultimate responsibility rests with the pool users who are homeowners or renters in the community and Association members.

b. The pool facilities were designed and built for the **primary** use and recreation of the Bluffs at Two Creeks Homeowners Association members and the Crossing at Two Creeks Homeowners Association members. In order to use the pool/recreation facilities the annual assessment must be paid in full.

c. Only Recreation Club members in good standing (i.e., have annual assessment fees paid, as required), their tenants, and their accompanied guests are permitted to use the pool and pool area.

d. Register-sign in when arriving at the pool and sign out when leaving. All guests must also be signed in and signed out when arriving and leaving the pool area.

1) This sign-in/sign-out register will serve as a factual source of information as to the days and times when the pool is used most frequently and by whom. It will also forecast any congestion problems and the need for additional lifeguards as our community grows.

(2) As conditions change and use of the pool increases, it may be necessary to make recommendations to the Board of Directors for changes such as the need for charging for guests, limiting the number of guests, more definitive rules for conduct, etc.

e. **Age Rules:**

**Under 12 - accompanied by responsible adult at all times.**

**12 + over - accompanied by adult unless lifeguard is on duty.**

**No one under the age of 18 may use the pool unless a lifeguard or responsible adult is present.**

Babysitters 16 or older may bring children to pool when lifeguard is present.

f. Close and lock all gates/doors upon entering and exiting facility.

g. Remove all personal belongings as you leave the pool. Any item(s) left overnight will be placed in the lost and found box and locked in the office and discarded after one week.

#### **4. GUESTS:**

a. Members in good standing may bring up to five (5) guests per family to the pool. The host member must accompany his/her guests at **all** times, and s(he) is responsible for his/her guest's conduct at all times.

b. The lifeguard(s) may request guests leave the pool in the matter concerning safety or over-crowding.

**c. A GUEST CANNOT BE A NON-PAID MEMBER OF THE RECREATION CLUB OR THE BLUFFS AT TWO CREEKS OR THE CROSSING AT TWO CREEKS HOMEOWNERS ASSOCIATION, I.E., MEMBERS WHO HAVE NOT PAID THEIR ASSESSMENTS. THESE MEMBERS MAY NOT ENTER THE POOL OR POOL AREA AS A GUEST OF A PAID MEMBER.**

#### **5. POOL CONDUCT RULES:**

a. **SMOKING IS ALLOWED OUTSIDE THE GATES.**

b. Pool users must be properly attired in appropriate swim wear for the gender. Females must wear bathing suits covering the top and bottom and males must wear bathing suits covering the bottom. No cut-off pants are permitted.

c. Children in diapers must wear water proof diapers while in the pool.

d. Persons with communicable, contagious diseases, open cuts or sores are not allowed in the pool.

e. Unless children demonstrate to the lifeguard their ability to swim, they must be accompanied by an adult while in the pool area. Children should not swim unless an adult is at home to be notified in the event of an emergency, illness, or conduct problems.

**Children under twelve (12) years old must be accompanied by an adult at all times.**

**Twelve (12) year old children are allowed to come without an adult when a lifeguard is on duty.**

**No one under the age of 18 may use the pool unless a lifeguard or responsible adult is present.**

f. A responsible adult must be within physical reach of a non-swimmer at all times.

g. Children above age five (5) are not permitted in the baby pool.

h. Running, rough play (in or out of the pool), excessive splashing, and diving from the sides

of the pool where marked "NO DIVING" is dangerous and not allowed. **Also, No Jumping/Diving from the lifeguard chairs.**

i. Glass, breakable items, and pets can be a health and safety hazard and are not allowed in the pool area. Dispose of cigarettes (SMOKING IS NOT ALLOWED INSIDE THE FENCE) and trash in the containers provided.

j. To prevent/avoid chemical imbalance or filter problems with the water, please:

(1) Towel or shower off suntan lotion or oil before entering the pool. Oil gums up tiles and dilutes the chemicals.

(2) Braid, confine in a pony tail or bun, or wear a bathing cap if hair is longer than shoulder length. Loose hair cannot be backwashed from the filter system and reduces its efficiency.

(3) Use only clean pool toys.

### **GENERAL POOL RULES**

Arm floats and plastic tube floats are not safety devices and must be used under adult supervision.

- a. Swim suits only. No cut off jeans. Water proof swim diapers must be worn in pool by children still in diapers.
- b. Persons with communicable contagious diseases or with open seeping wounds are not allowed in the pool.
- c. Any person under the influence of drugs and/or alcohol or acting in violation of the rules herein is not allowed in the pool area.
- d. Smoking allowed only outside of pool gates.
- e. Association is not responsible for items which are lost, damaged or stolen.
- f. Safety equipment is to be used only in case of emergencies.
- g. Any vandalism done to the pool, playground, clubhouse, tennis courts, or sport court will be dealt with in accordance with the Texas State Law.
- h. Youth not complying with rules will be given two warnings only. If unacceptable behavior continues, they will be given a 5 - 10 minute time out under the pavilion. If that has no effect, a parent will be notified to pick up the child and they will not be able to swim the rest of the day.

**When a lifeguard is on duty, he/she has full and final authority  
on all matters concerning the pool.**

**These rules were adopted using the guidelines of the  
American Red Cross and City and State Safety Guidelines and Codes.  
They are to guarantee all safety, sanitary, and appropriate operating directives are met.  
They are to protect the enjoyment and safety of all  
pool members. Thank you for your cooperation.**

### **ADDITIONAL POOL RULES**

1. All members must register their family and guests and accompany them at all times (limit of 5 guests per family).
2. No **GLASS** within pool enclosure.
3. Food and drink allowed only under pool house pavilion. **NO gum.**
4. Smoking allowed only outside of pool gates.
5. Walk - don't run.
6. No pushing, fighting, dunking, towel snapping or horseplay.
7. Do not distract the lifeguard on duty unless an emergency.
8. Gates must be kept locked when no lifeguard is on duty.
9. No large pool toys allowed in pool unless approved by the lifeguards on duty.
10. Toys are allowed at the discretion of the lifeguards.
11. No pets allowed within the pool gates.
12. Baby pool is to be used only by children five (5) and under. Water proof swim diapers must be worn by children still in diapers.
13. An adult must accompany any child under 12 during lifeguard season. Children under 18 may not use the pool during off-season without adult supervision. Parents are responsible for the supervision and actions of their children.

### Sports Court, Tennis Court and Playground Rules

1. No pets allowed within perimeter of sports court or tennis court.
2. No pets allowed within landscaped area of playground.
3. No more than five (5) guests per family allowed at any one time on sports court, tennis court and/or playground.
4. No scooters, roller blades, roller skates, skateboards or bicycles allowed on the tennis court.
5. **NO GLASS CONTAINERS ALLOWED.**
6. Pick up all (**plastic**) soda bottles, cans and trash after using the area.
7. There is a 45 minute time limit on the sports court. If there are people waiting to use the court, please surrender the court at the end of that time period.
